Each party revocably submits to the jurisdiction of the Los Angeles County courts and the revocably agree that venue would be proper in said courts, and hereby waive any objection that any such chosen court is an improper or inconvenient forum for the resolution of any suit, action or proceeding relating to this agreement.

### ACCOUNT AGREEMENT AND TERMS OF SALE

The undersigned hereby applies to Forest Plywood or Baker Hardwood for credit. It is understood and agreed that the undersigned specifically consents to Forest Plywood or Baker Hardwood investigating the applicant's credit history who may utilize outside credit reporting services to obtain information on the undersigned.
